Booking Terms & Conditions:

- i. Booking will only be held for 14 days once deposit is requested
- ii. All bookings will be treated as tentative until deposit received
- iii. Deposit will be the total cost of 1 nights stay or \$500 in case of whole site booking
- iv. Deposits will be deducted from your final invoice and can not be 'rolled over' to future bookings
- v. Full payment is required on arrival including any bond (See Booking Form for bonds)
 - **BONDS** cover lost keys, damage, extra cleaning. Return of Bond is at wardens discretion and their decision is final.
- vi. Prices on day of arrival will be those charged, NOT at time of booking
 - Management will advise of any price increase over 10% from time of booking prior to arrival
- Deposits will be forfeited if cancellation is within 14 days of arrival except in cases of price rise see item (vi)
- viii. Cheques payable to Caringal Scout Camp
- ix. Scout Groups NOT Scouting families taking part in bona fide scouting activities receive a 30% discount on buildings. Camping fees are \$5 per head per night. No site fees are charged.
- x. Bookings for cabins over public holiday weekends will be for minimum 2 nights. From 21st Dec to 5th Jan 3 nights minimum

- xi. Equivalent of 1 x wheel barrow of wood is supplied to cabins for wood burning heaters. Extra wood is available for \$20 per wheelbarrow load see warden. This is not for BBQs or campfires.
- xii. **BE ADVISED** all water in cabins/mess hall/toilets and on sites is tank water from the river and should be boiled prior to consumption
- xiii. Dogs MUST be on a lead/leash at all times. Dogs must not be left unattended
 - Pets allowed to worry wildlife or other campers will result in owners being asked to leave
- xiv. No motorcycles/trail bikes or horses allowed on site ant anytime without express permission of the District Commissioner/Camp Manager.
- xv. Sites may be changed at Wardens discretion dependent on ground conditions or other factors
- xvi. Caringal Scout Camp is run under the Scouts Victoria code of conduct and site rules apply. An example of which, but not limited to, are:
 - Campers or users of the site should not be intoxicated
 - No drugs except prescription drugs are allowed on site
 - · Campers should behave in a courteous manner towards other users and staff at all times
 - Scouts Victoria does not tolerate threats, abuse or violence towards its members and any incidents will
 result in the person(s) being asked to leave and a Police report made. Legal action will be taken and a ban
 imposed
- xvii. FIRES should only be lit in fire drums supplied. No fires to be lit on or in the ground
 - During hot weather fire bans may be enforced independent of State/Zone ones.
 - IF CFA rating is Very High, Severe, Extreme or Code Red NO OPEN FIRES ALLOWED
 - Unattended fires <u>WILL BE EXTINGUISHED</u>

xviii. Scouts Victoria approves the Hirer's use of the facility on the following conditions:

- It is the responsibility of the Hirer to use the facility for the approved use only and to indemnify Scouts and hold harmless from and against all damages, costs, actions, claims and demands that may be sustained or suffered or recovered against Scouts by the Hirer, its servants and employees, or any other person whatsoever.

- The Hirer acknowledges that to the fullest extent permitted by law, Scouts its servants and agents
 are not under any liability to the Hirer or to any third party for any loss of or damage to any
 property or injury suffered. This includes any legal liability that may otherwise arise as a result of
 any direct or indirect act, neglect or default by Scouts or any of its servants or agents.
